- ✓ I am aware that in case of failure to submit the result of the RT-PCR test for the presence of SARS-CoV-2, the Regional Hygiene Station will decide on quarantine measures or ordered isolation in accordance with Act No. 258/2000 Coll. on the protection of public health;
