**Mandatory testing of people accommodated in the dormitories of The
University of Economics in Prague**

In connection with the Resolution of the Government of the Czech Republic of 19th of April 2021 No. 393 on extraordinary measures of the Ministry of Health, namely its Annex No. 2 - "Extraordinary measures laying down the conditions for testing students at Universities" I issue the following order of the director:

1. Starting on 24th of April 2021 00:00 only residents with a valid negative test for the presence of the SARS-CoV-2 virus may stay and enter the VŠE dormitories. The following are considered valid:
 - a. confirmation of a negative test result of the POC antigen test for SARS CoV 2 virus or RT PCR test for SARS-CoV-2 virus, which is not older than 48 hours and which was performed and issued by the health service provider according to the currently valid emergency measure of the Ministry of Health tests, or
 - b. confirmation of the test performed at the University of Economics in Prague or at another public university, or
 - c. a statutory declaration on the negative result of the antigen test for the presence of SARS-CoV-2 virus antigen, which is intended for self-testing or authorized by the Ministry of Health for use by a lay person, which was issued to the accommodated person by the reception of the relevant dormitory.
2. The above in point 1 does not apply to the accommodated person who proves that:
 - a. has undergone laboratory-confirmed disease COVID-19 and has expired in accordance with the applicable emergency measure of the Ministry of Health and no more than 90 days have elapsed since the first positive POC antigen test for SARS CoV 2 antigen or RT-PCR test for SARS CoV 2 virus, or
 - b. has a certificate issued by the Ministry of Health of the Czech Republic on vaccination against COVID-19 and at least 14 days have elapsed since the application of the second dose of vaccine in the case of a two-dose schedule and at least 14 days have elapsed since the first dose of vaccine was administered in the case of a single dose schedule.
3. A negative test result according to point 1 shall be documented once every 7 days.
4. The accommodated person who does not prove the circumstances according to point 1. a., 1. b., or point 2 upon arrival at the dormitory shall undergo the antigen test according to point 1. c. at the reception of the relevant dormitory. The test costs CZK 128 and the receivable in this amount will be charged to the ISKAM accommodated upon collection. So far, however, there

is the possibility of a refund from the state. If this happens, the receivable in ISKAM will be deleted. He must not enter the dormitory until the guest has presented a negative test result.

5. Upon submission of a positive test result, the accommodated person is obliged to immediately leave the premises of the VŠE dormitory in which he / she is accommodated or to accept the immediate placement in a quarantine room designated by the SÚZ VŠE employee in Prague.
6. The accommodated person with a positive test result which he / she performed according to point 1. c. is obliged to inform the provider of health services in the field of general practical medicine about the positive test result by telephone or in another usual remote way.
7. Failure to comply with or violate the above measures may be punished by law and will be considered a gross violation of the general accommodation conditions.

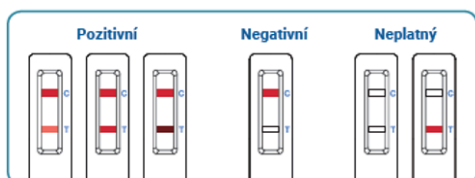

Instructions

You must not eat or drink for two hours before performing the test.

Remove the swab stick from the package and gently insert the swab into the oral cavity and allow the sponge to soak naturally with saliva until the dot on the firm side of the swab turns into blue - approx. 90 seconds. See also the illustration on the packaging of the swab stick.

Remove the test card from the package and snap the swab rod into the rectangular test site with the swab down. Leave the test to stand for 15 minutes. Evaluate the test result according to the following scheme:



After use, throw the test kit into a designated waste container. In case of an invalid test, pick up a new test at the dormitory reception. If the test is positive, you are obliged to inform the health service provider in the field of general practice about the positive test by telephone or other usual remote method.
