Measures against the spread of COVID-19 disease at the dormitories of the University of Economics in Prague

With effect from 28 August 2020, I declare these measures against the spread of COVID-19 in the dormitories of the University of Economics in Prague:

- 1) All indoor sports and social facilities on the dormitories are still closed to guests. These are gyms, gyms, study rooms, games rooms, projection rooms and the like. (Does not include laundries.)
- 2) Starting on 1th of September 2020, it is the duty to wear in the corridors of dormitories and in laundries mask or respirator.
- 3) All mass events (celebrations) on the dormitories are prohibited. It is also forbidden to gather in the dormitory rooms under any pretext. Mutual visits must be limited to the minimum necessary and for the shortest possible period.
- 4) Dormitory staff are obliged to monitor the current measures on a daily basis on the website: <u>https://koronavirus.mzcr.cz/aktualni-opatreni/</u> and emergency measures on the website: <u>https://koronavirus.mczr.cz/category/mimoradna-opatreni/</u> and derive from the information adequate measures for the operation of the dormitories.
- 5) People arriving from the countries listed on the website: https://koronavirus.mzcr.cz/seznam-zemi-podle-miry-rizika-nakazy/ as countries with a high risk of infection, must prove a negative test for COVID-19 issued in the countries of the European Union, which is not older than two days.
- 6) People arriving from countries listed by the Ministry of Health of the Czech Republic in countries with a low incidence of the disease do not have to submit a COVID-19 test during accommodation. This list is continuously updated.
- 7) People arriving from countries that are not listed above by the Ministry of Health of the Czech Republic must prove a negative test for COVID-19 issued in the Czech Republic (airports,..) or in a European Union country not older than 48 hours. People without a negative test for COVID-19 can in no case be admitted to the premises of VŠE dormitories (they cannot even be provided with alternative accommodation at VŠE dormitories).
- 8) All people accommodated in the VŠE dormitories are obliged to have their body temperature measured with a non-contact thermometer upon request. The head of the dormitory will ensure that the reception staff randomly measures the body temperature of people coming to the dormitory several times a day. The receptionist shall make a written record of this measurement in a dedicated record sheet, in which they shall state the day, time and number of measured persons with a temperature not exceeding 37.5°C and the names of the surnames of people whose body temperature exceeded this value. People who show any of the symptoms of COVID-19 (temperature 37.5°C, dry cough, dyspnoea) will be immediately placed in a quarantine unit, instructed on compliance with the rules of quarantine.
