Rules for the arrival of people to Czech Republic and documentation of negative results of antigen tests and RT-PCR test for the presence of SARS CoV-2 and quarantine measures during accommodation at the dormitories of the University of Economics in Prague.

With effect from 5th of February 2021 in connection with the Protective Measure of the Ministry of Health of 1st of February 2021 I declare the following measures for the submission of the RT-PCR test for the presence of SARS CoV-2:

 People (foreigners and citizens of the Czech Republic) who entered the territory of the Czech Republic from 5th of February 2021 from 00:00 are obliged in case of any symptoms of an incipient infectious disease (especially fever, cough, shortness of breath, indigestion, loss of smell, general weakness, or other symptoms) immediately notify the staff of the relevant dormitory (reception, dormitory manager) at which they have booked accommodation. The reception staff or the head of the dormitory will measure the temperature of all people (foreigners and citizens of the Czech Republic) who entered the territory of the Czech Republic from 5th of February 2021 at 00:00 and evaluate whether it does not exceed 37.5 ° C.

The head of the dormitory places will move people showing symptoms of incipient COVID-19 or elevated temperature to the quarantine room and reports this fact to the appropriate hygiene station. These people will remain in the quarantine room until a negative RT-PCR test is submitted.

- 2) People (foreigners and citizens of the Czech Republic) who came to the Czech Republic from countries with a medium risk of COVID-19 in which they stayed for more than 12 hours in the last 14 days (see the communication of the Ministry of Health of 1st of February 2021 Ref. : MZDR 20599 / 2020-52 / MIN / KAN):
 - a. submit to the staff of the dormitory (reception, head of the dormitory) a document on the completion of the electronic Arrival Form (notification) during the border or residence check,
 - b. submit to the staff of the dormitory (reception, head of the dormitory) a written confirmation of the accredited laboratory about the negative result of the antigen or RT-PCR test; the test must be performed no more than 48 hours before the start of the journey.
- 3) People (foreigners and citizens of the Czech Republic) who came to the Czech Republic from countries with a high risk of COVID-19 in which they stayed for more than 12 hours in the last

14 days (see the communication of the Ministry of Health of 1^{st} of February 2021 Ref. : MZDR 20599 / 2020-52 / MIN / KAN):

- a. submit to the staff of the dormitory (reception, head of the dormitory) a document on the completion of the electronic Arrival Form (notification) during the border or residence check,
- submit to the staff of the dormitory (reception, head of the dormitory) a written confirmation of the accredited laboratory about the negative result of the antigen or RT-PCR test; the test must be carried out not more than 48 hours before the start of the journey,
- c. after entering the territory of the Czech Republic, they will undergo an RT-PCR test for the presence of SARS-CoV-2 within 5 days at their own expense and immediately submit the result electronically to the regional hygienic station appropriate to the place of stay specified). Until the submission of a negative RT-PCR test performed in the Czech Republic, these persons will be placed in a quarantine room. This fact is reported by the head of the dormitory to the relevant hygienic station.
- d. if necessary, they move outside the quarantine room with an FFP2 respirator (or at least a mask).
- People (foreigners and citizens of the Czech Republic) who came to the Czech Republic from countries with a very high risk of COVID-19 in which they stayed for more than 12 hours in the last 14 days (see the communication of the Ministry of Health of 1st of February 2021 No. j .: MZDR 20599 / 2020-52 / MIN / KAN):
 - a. submit to the staff of the dormitory (reception, head of the dormitory) a document on the completion of the electronic Arrival Form (notification) during the border or residence check,
 - b. submit a written confirmation of the negative result of the RT-PCR test to the staff of the dormitory (reception, dormitory manager); the test must be carried out not more than 48 hours before the start of the journey,
 - c. after entering the territory of the Czech Republic, they will undergo an RT-PCR test for the presence of SARS-CoV-2 within 5 days at their own expense and immediately submit the result electronically to the regional hygienic station appropriate to the place of stay specified). Until the submission of a negative RT-PCR test performed in the Czech Republic, these persons will be placed in a quarantine room. This fact is reported by the head of the dormitory to the relevant hygienic station
 - d. if necessary, they move outside the quarantine room with the FFP2 respirator.
- 5) Heads of dormitories are obliged to regularly monitor the relevant pages of the Ministry of Health and respect the instructions and changes in the list of categorization of countries according to the risk of COVID-19.
